By participating in the We Save program, you can save energy and earn a rebate when you purchase a new ENERGY STAR® certified appliance and/or recycle an operating refrigerator or freezer.

What rebates can I earn?

ENERGY STAR Certified Refrigerator Rebate = \$25
ENERGY STAR Certified Freezer Rebate = \$25
ENERGY STAR Certified Dishwasher Rebate = \$25
ENERGY STAR Certified Clothes Washer Rebate = \$25
ENERGY STAR Certified Dehumidifier Rebate = \$25
Recycling Bonus Rebate (Refrigerator or Freezer) = \$50

What does it mean to be ENERGY STAR Certified?

- ENERGY STAR certified refrigerators are 9 to 10% more efficient than non-qualified refrigerators.
- ENERGY STAR certified freezers are at least 10% more efficient than non-qualified freezers.
- ENERGY STAR certified dishwashers are 12% more efficient and use less water than non-qualified dishwashers.
- ENERGY STAR certified clothes washers are 25% more efficient and use 40% less water than non-qualified clothes washers.
- ENERGY STAR certified dehumidifiers are 15% more efficient than non-qualified models.

How Do I Qualify?

- Residential customers receiving electric service from a local municipal electric utility that is a participating member of MMPA are eligible for rebates when buying ENERGY STAR certified appliances.
- Appliance must be installed in a home that receives electric service from a local municipal utility that is a participating member of MMPA.
- **ENERGY STAR certified appliances must be labeled accordingly and be on current ENERGY STAR list at the time of purchase. (Ask your dealer which models are currently listed.)**
- **To qualify for Recycling Bonus rebate, unit must be in operating condition prior to removal and proof of recycling must be provided. If unit is hauled away, retailer must certify that unit will be recycled and not resold (Step 3 of rebate application).**
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebate applications must include complete retailer and appliance information; a copy of dated sales receipt showing manufacturer and model number; and a copy of EnergyGuide label. (Exception: Dehumidifiers do not have EnergyGuide label.) Incomplete rebate applications will not be processed.
- Limit one rebate per appliance per customer account per year.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2017.
